What is 3-D Secure?

3-D Secure (3DS) is a security standard developed by the major payment card brands—Visa, MasterCard, American Express, Discover, and JCB—that provides an extra layer of protection for online credit and debit card transactions. By enabling cardholders to authenticate themselves to card issuers when making e-commerce and m-commerce purchases, 3DS reduces merchants' exposure to fraud.

3DS Compliance Requirements

The 3DS standards apply to Core Components used by merchants and banks—Access Control Server, Directory Server, and 3DS Server—as well as System Development Kit (SDK) software used in 3DS mobile applications.
