Which Assessment Option is Best for You?

In October 2021, HITRUST announced two new assessment options to accommodate organizations with different levels of risk exposure. With these additions, HITRUST now offers three assessment alternatives:

- **The Basic, Current-State (bC) Assessment (New).** Suitable for lower-risk scenarios.
- **The Implemented, 1-Year (i1) Validated Assessment (New).** Suitable for moderate-risk scenarios or where a baseline risk assessment is needed.
- **Risk-Based, 2-Year(r2) Validated Assessment (Current).** Suitable for higher-risk scenarios.
